

The Elyria City School District Internet Use Agreement
Updated: September 24, 2015

The Internet is the communication medium of the 21st Century and allows access to a wealth of information. With this access comes the availability of material that may be illegal, defamatory, inaccurate, or potentially offensive. The Elyria School District has a filter on the internet which blocks much of this type of information; however, no filter is 100% infallible. Industrious users may discover controversial information or ways around the filter. We believe that the benefits to students from the Internet, in the form of information resources and opportunities, exceed the disadvantages. But ultimately, parents and guardians of minors are responsible for setting and conveying the standards that their children should follow when using media and information sources.

Internet access is a privilege, not a right. Before access is granted, students and parents are required to view and discuss the online safety videos located at: <http://bit.ly/1FiMz6o> The following guidelines must be adhered to or privileges will be revoked.

1. **Acceptable Use** – Use of the Internet will be in support of the educational objectives of the Elyria Schools and acceptable use is outlined in Board of Education policy EDE and in the study handbook.
2. **Vandalism and Harassment** – will result in cancellation of privileges and possible legal action. Vandalism is defined as any malicious attempt to harm school equipment or destroy data of another user or other networks that are connected to the internet. This includes, but is not limited to, the uploading or creation of computer viruses. Harassment is defined as the persistent annoyance of another user or the interference in another's work. This includes, but is not limited to, the sending of unwanted mail, text messages or through social media postings.
4. **Filter and Security** – Bypassing or attempting to bypass the internet filter or security systems is strictly prohibited.
5. **Penalties** – Any user violating this agreement or applicable state and federal laws or posted classroom and District rules, is subject to loss of network privileges and any other District disciplinary options as set forth in the *Code of Pupil Conduct*. This could result in criminal prosecution.

School and District administrators will make the final determination as to what constitutes unacceptable use and their decision is final. The Elyria City School District makes no warranties of any kind, whether expressed or implied, for the service it is providing. The District will not be responsible for any damages a user may suffer, including loss of data. The District will not be responsible for the accuracy or quality of information obtained through this internet connection.

As the parent or guardian of this student, I have read and agree with the **Internet Use Agreement**. I understand that this access is designed for educational purposes. I also recognize it is impossible for materials acquired on the network, including, but not limited to, claims that may arise from the unauthorized use of the system to purchase products or services. I also accept financial responsibility for acts of vandalism (see #3 Guidelines) committed by my child. I will instruct my child regarding any restriction I have for them against accessing materials that are in addition to the restrictions set forth in the **District's Internet Use Agreement**. I have viewed the online safety videos and discussed with my child the importance of following the rules for online safety. Further, I accept full responsibility for supervision, if and when my child's use is not in a school setting.
