Franklin County Schools Transportation Department is excited about the 22-23 school year. We ask that you be patient and understanding with our department as we maneuver through staff shortages. We work diligently each day to transport students safely and efficiently. Be aware that there will be days that you will receive a message via school messenger making you aware that your child will need alternate transportation. We are making you aware so you can start making a plan for your student on these occasions. Please make sure the information you enter into PowerSchool Registration is correct. Messages will be conducted based on school bus numbers. Please be aware of the bus number your student rides. If the address or phone number is not correct in PowerSchool Registration you will not receive accurate information. Feel free to call our office (540) 483-5541 to verify correct information. Continue to check bus information on the website through the first day of school. Each day routes are updated due to new enrollees.

Below you will find information regarding STAR Routes. These routes will be used when we have a driver shortage that involves a **secondary bus route** in the morning only. Parents/Guardians will be asked to drive their student to school or to one of the following pickup locations that relates to your student's bus number. When there is a driver shortage on an **elementary bus route**, a message will go out stating that you will need to provide transportation for your student to and/or from school. We apologize for any inconvenience this may cause the community. If you or if you know of someone that would be interested in driving a school bus please send them our way. Again, we appreciate your understanding during this time.

STAR - Secondary Transportation Alternate Routes - AM ONLY

Parents must stay with the student until they board the AM bus.

Students who board within the town limits will need to be transported by parent or guardian to school
