HEALTH & SAFETY PROTOCOL



VISITORS

Schools will have traditional activities physically open to parents, guardians, and community.

TRAINING

Professional development will be provided for staff on hygiene and sanitizing procedures as well as screening measures.

HAND WASHING

A hand washing protocol for each building has been established. Additional hand sanitizer will be available.

CLINIC

Symptomatic students waiting for pickup will be provided a separate space.

MASKS

BSD will follow the Governor's Executive Orders. July 1, 2021: Masks Optional

WATER BOTTLES

Students are encouraged to bring their own filled water bottles. Alternative filling stations will be available.
