

# NOTIFICATION OF RELEASE OF INFORMATION OF STUDENTS IN GRADES 10-12 PURSUANT TO FEDERAL AND STATE LAW

The District is required to provide the addresses and phone numbers of students in grades ten through twelve to a recruiting officer for any branch of the United States armed forces who requests such information, any student data provided by the District to a recruiting officer shall be used solely for the purpose of providing information to students regarding military service and shall not be released to any person other than individuals within the recruiting services of the armed forces.

The District will NOT release this information if a parent, guardian, custodian, or eligible student submits a written request not to provide this information.

RETURN THIS FORM ONLY IF YOU DO NOT WANT YOUR STUDENT'S ADDRESS PROVIDED TO RECRUITING OFFICERS FOR THE UNITED STATES ARMED FORCES.

Directory information means information contained in an education record of a student that would not generally be considered harmful or an invasion of privacy if disclosed. Therefore, prior consent is not legally required before using or releasing directory information.

The Akron Board of Education in its Board Policy 8330 designates as "directory information" to include only a student's name; major field of study; participation in officially recognized activities and sports; date and place of birth; photograph\*; height and weight, if a member of an athletic team; dates of attendance; date of graduation; or awards received.

\*photograph consists e.g., the student's official photo as maintained in the student's cumulative file and/or a photograph used for purposes of identification and/or legitimate school sponsored programs(s).

## **Directory information will never be used for or provided to any individual or organization for profit-making purposes.**

If you do not want the District to disclose directory information without your prior written consent, you must complete the following opt-out form and return it to the school. Additional information regarding student records may be found in Board Policy 8330.

If you choose "OPT - OUT" please choose the information from the check list, sign and return the stub to the students school.
