On Monday, November 16, 2020 at 8:00 PM, the Glen Rock Board of Education will hold a virtual meeting in the High School/Middle School Cafeteria, 400 Hamilton Avenue, Glen Rock, N.J. for the purpose of holding a Regular Board meeting. The agenda for the meeting will be as follows: General, Business and Personnel. Action will be taken.

Due to capacity restrictions imposed by Governor Murphy's Executive Orders, members of the public desiring to attend any meeting in person must email [boardsecretary@glenrocknj.org](mailto:boardsecretary@glenrocknj.org) seven days before the meeting but not later than noon on the day of the meeting to provide their name and their desire to attend. The Administrative Assistant to the Business Administrator/Board Secretary will place the names of all interested in attending the meeting and select names randomly. Members of the public will be notified by 3:00 p.m. only if their names were chosen in the lottery. Until the capacity restrictions of twenty-five people for an in-person gathering are lifted, no more than ten members of the public may attend a Board meeting in person due to the number of Board members, administrators, and staff present in the meeting room.
